Dear Mrs. Rolls:

Further to my letter of the 10th October, 1944, I regret to inform you that in view of the length of time which has elapsed since your husband, Raymond Burton Rolls, Able Seaman, Official Number V-34863, Royal Canadian Naval Volunter Reserve, was reported missing from H.M.C.S. "ATHABASKAN", and as no news has since been received to the contrary, the Canadian Naval Authorities have now presumed his death to have occurred on the 29th of April, 1944.

May I again express sincere sympathy with you in your bereavement on behalf of the Minister of National Defence for Naval Services, the Chief of the Naval Staff, and the Officers and men of the Royal Yours sincerely, Canadian Navy.

THIS IS TO CERTIFY that according to official information Raymond Burton Rolls, Able Seaman, Official Number V-34863, Royal Canadian Naval Volunteer Reserve, is missing, presumed dead to date the 29th of April, 1944, when the ship in which he was serving, H.M.C.S. "ATHABASKAN", was torpedoed and sunk by enemy action in the English Channel.
