Dear Mr. Evans: -Further to my letter of the 23rd August, details of the disaster in which your son has been reported missing are now being released. H.M.C.S. "ALBERNI" was sunk while on invasion duties in the English Channel. Four officers and fifty-five ratings are missing, with three officers and twenty-eight ratings having survived. It is regretted that the position of the loss cannot be given, but it is considered unlikely that prisoners of war will be taken. It is requested that you will keep this information in confidence until an official announcement is made. May I again express sincere sympathy with you in your anxiety. The only minor comfort I can give you is that he was down below at the time the ship was hit and as the ship sank instantly I am sure he did not suffer any pain.
