Dear Mr. Wright: -Further to my letter of the 23rd August, details of the disaster in which your son has been reported missing are now being released. H. M. C.S. "ALBERNI" was sunk while on invasion duties in the English Channel. Four officers and fifty-five ratings are missing, with three officers and twenty-eight ratings having survived. It is regretted that the position of the loss cannot be given, but it is considered unlikely that prisoners of war will be taken. It is requested that you will keep this information in confidence until an official announcement is made. C.R. BY .... May I again express sincere sympathy with you in your anxiety. THIS IS TO CERTIFY that according to official information Thomas Wright, Stoker First Class, Official Number V-66434, Royal Canadian Naval Volunteer Reserve, is missing, presumed killed on the 21st of August, 1944, when the ship in which he was serving, H.M.C.S. "ALBERNI", was lost in the English Channel due to enemy action.
