Dear Madam: It is with deep regret that I must confirm the telegram sent out by the Minister of National Defence, reporting that your son, Selwyn Ruse Heycock, Able Seaman, O.N. 3283, R.C.N., was missing, believed killed. Few details are available, but it is known that H.M.C.S. "MARGAREE" was sunk in collision in the North Atlantic whilst steaming without lights, on convoy duty, and in the submarine zone. 142 Officers and ratings are missing and must be presumed lost at sea. I am requested to express to you the sincere sympathy of the Minister of National Defence for Naval Services and the Chief of the Naval Staff in your bereavement.
