Destruction of Conduct Sheet.—Attention is directed to Art. 603, cl. 3, K.R., which provides for the destruction, after the next assessment of character, of a Conduct Sheet shewing the record of offences in a previous ship.

3. Class for Conduct.—The date of proposed restoration may be any date not less than 3 months and not more than 6 calendar months from date of reduction. See Art. 567, K.R.

4. Good Conduct Medal and Gratuity.—Recommendations are to be made according to the instructions in Arts. 534, cl. 3, and 606, cl. 4, K.R. If the recommendation is intentionally withheld, a statement to that effect should be inserted. (See Art. 534, cl. 15.)

Dear Madam:

It is with deepest regret that I must confirm the telegram of the 26th September from the Minister of National Defence for Naval Services informing you that your son, George Earl Jaynes, Stoker I, O.N. 21786, R.C.N., has been killed in action.

H.M.C.S. "LEVIS" in which he was serving was in contact with enemy units on the 19th September and was subsequently sunk. It has been definitely established that your son lost his life in face of the enemy. The exact circumstances of the action must remain secret for the present observing that the information would be useful to the enemy.

I am directed to express to you in your bereavement the sincere sympathy of the Chief of the Naval Staff, the Officer and men of the Royal Canadian Navy, the high traditions of which your son has helped to maintain.
